Reference is hereby made to (i) the €1,050,000,000 7.75 per cent. notes due 2033 of Telecom Italia Finance (the “**Issuer**”) guaranteed by Telecom Italia S.p.A issued under its Euro Medium Term Note Programme, admitted to trading on the regulated market of the Luxembourg Stock Exchange and listed on the Official List and (ii) the €1,300,000,000 6.125 per cent. mandatory convertible bonds of the Issuer due 13 November 2033, admitted to trading on the Third Market of the Vienna Stock Exchange.

Notice is hereby given by the Issuer that, as previously announced by the Issuer, Telecom Italia International N.V, a public company with limited liability (*naamloze vennootschap*) incorporated under the laws of the Netherlands (the “**Absorbed Company**”), merged with Telecom Italia Finance (the “**Merger**”). The Merger was completed on 28 July 2016.

Pursuant to the Merger, the merging companies have effected a cross-border merger whereby the Absorbed Company merged with Telecom Italia Finance (the “**Absorbing Company**”) as a result of which the Absorbed Company ceased to exist and the Absorbing Company absorbed all assets and liabilities of the Absorbed Company under universal succession of title.

For accounting purposes, the transfer of the assets and liabilities under universal succession of title of the Absorbed Company to the Absorbing Company became effective as from 1 January 2016. Besides, the activities and business operations of the Absorbed Company are continued by the Absorbing Company in the same manner.

The general meeting of shareholders of Telecom Italia Finance approving the Merger was held at the premises of Linklaters LLP, 35, Avenue John F. Kennedy, L-1855 Luxembourg, Grand Duchy of Luxembourg on 28 July 2016 at 6:00 pm (Luxembourg time). The minutes of this general meeting of shareholders of Telecom Italia Finance were published with the Luxembourg *Recueil Electronique des Sociétés et Association* n° 2016_053 dated 1st August 2016.
